ANNUAL SPRING MEETING AT PRINCE GEORGES COUNTRY CLUB April 28, 1981

A banner turnout of 65 MISGA Associates from 29 country clubs board members attended this annual meeting and enjoyed an afternoon of golf at Prince George's new facility.

Both activities were enimently successful in that a number objectives were met during the course of the meeting (summarized below) and the golf play was (almost) sparkling on a truly difficult and beautiful course. It is a pleasure to inform those MISGA Assocciates who plan to play at PGCC that it is in excellent shape, especially considering that it has been open for play for less than less than 6 months.

The meeting was opened by Al Hagen, Executive Director, who introduced Gil Williams, Chairman of Operations Liaison Committee. Gil introduced his Division Representatives and explained the procedure for keeping the membership informed. He called attention to MISGA's goals and objectives included in a handout and provided the clubs with a list of club reps and the division reps.

We have 3 new member clubs: Wakefield Valley, Crofton and Chester River. Mel Gesell, club rep. at Wakefield Valley, received a congratulatory LOGO which he will hang in the club house. The other two clubs will also receive their logos. Speaking of mixers Argyle has 17 of them! It also has a billfold size printed schedule, a convenience that all clubs should try to emulate.

Al Hagen turned to the consideration of a new location for the Spring Fling, noting that the objective was to be able to accomodate many more golfers—up to 280. One candidate is Fox Fire near Pinehurst. An ad hoc Spring Fling committee is looking into this and will have a report for the June board meeting. Several persons called attention to the possibility of poor weather and thin grass in North Carolina in late March-early April and the lack of

things to do for the nongolfing ladies.

After a break, Dave Watson discussed logistics for the Eastern Shore Invitational on May 6 and 7. He announced that qualifying rounds for the Fall Championship would be held during the second week in September and the final round would be a Lakewood on September 25.

Sam Hastings then explained the club allocation of qualifying slots which had been previously approved in principle. In brief each club is to be given that number of team slots at each qualifying location proportional to the club's percentage of membership in MISGA.

After considerable discussion about whether to limit club representation to a single team in the final round, Bill Woolston moved and Don Rice seconded that all qualifiers regardless of club affiliation be eligible to compete for the championship. The motion was carried with enthusiasm.

THE SPRING FLING

T is column is not for the benefit of the 48 happy MISGA Associates and their wives who attended--it is for the information of the approximately 1700 Associates who didn't apply for a place when applications were being taken last August. The attendees know the format that was followed, the excellent camaraderie developed, and the fine accommodations and meals provided as part of the package. I'll tell you something about these positive aspects after I discuss the matter of attendance which is important as evidenced by concern expressed to me by both MISGA directors and associates. Of the 38 clubs comprising MISGA, only 15 were represented. This maldistribution and. to a certain extent, associated lack of receipt of applications probably arises from five important factors:

Many Misga Associates don't know about the Fling

= Some Associates think the package is too expensive

Some think the Fling is too long and too far away - which puts a strain on family relations

= Some think that there is no point in applying for a place because 2 or 3 clubs hog the slots anyway

= Some would prefer the fling to be held one week earlier to avoid conflicts with home club opening MISGA events

Taking these in order, the first point is certainly valid as I can personally attest: This is my third year as a dISGA Associate and my first Spring ling. I missed the two previous lings only BECAUSE I didn't know about them. This situation was caused by nadequate communication from the Board own to the Associate, a situation that s being significantly improved for 981 (more on this elsewhere in this ISGAgram).

This doesn't include a couple of other goodies such as two open bar cocktail parties and a group golf lesson given by the Holiday Inn's resident pro. I didn't include these because not all persons participate in these events —although I can assure you that the cocktail parties were well attended.

The third point - that the Fling is too long and too far away, especially for those with family responsibilities, is certainly worth examining noting however that there are tradeoffs as we pull back closer to home. Two of these are that as you get closer, the weather gets poorer and the price gets richer. Nonetheless the package could be priced at about the same figure at per haps one third less distance if the Fling were shortened by one day. Associates' comments are solicited.

The fourth point -that many Associates are discouraged from applying for a place because of monopolization of slots by a few clubs has a reverse side to the coin. That is that these clubs take slots only because other clubs do not do so. There are several solutions to this problem including proportional allocation of slots and by greatly enlarging the size of the Fling, say by a factor of 3 or 4.

The final point - about advancing the Fling date by a week. Past experiences dictate we schedule as late as possible because of better weather and course conditions. This means it falls in the week before Holy Week. This should not conflict with MIXER schedules at home because all major tournament dates are published in October.

SPRING FLING cont'd

Speaking of meals, as we were a while back, most of us took advantage of being able to "eat out" at two establishments. At one, a seafood house, we ate without menu restriction. At the other, an Italian restaurant, we were allowed at \$9 credit but we had a snugly waitress who was a supersaleswoman and we bought everything that she suggested, running up a pretty good "extras" bill. Earlier Tony, the owner of the restaurant, greeted some of the golfing wives on the fairway side of his home at the SURF C.C. and offered them bloody Marys as a demonstration, I think, of his hospitality.

The Fling started with a scrambler which was highlighted by a classic faux pas by one of the sub par shooting groups consisting of Ed Schmidt, Larry Ring, Bruce Holly and Henry Galotta. After a putt to within a few inches of the hole by the first putter, he holedoout and the three other members of the foursome could not take shots at the bird.

The next day's play was a 2 Net Best Ball of Foursome which did not produce anything notable except the spread of scores which included a spectacular 130 on down to a drooping 148. Wednesday and Friday play was for low net and low gross championships with A players paired with Cs and Bs with Ds. Luck of the draw was also used for the two-man teams and this format succeeded in getting most Associates playing with different people each day. This good mix is a continuing MISGA objective and at the Spring Fling it was realized because by the Friday night awards dinner most Associates were on a first name basis.

We are grateful to (1) Clyde Phillipps, Larry Ring & Willis Warren our welcoming committee; (2) Ed Schmidt, Sam Hastings, Bill Woolston & Gil Williams who so ably conducted the men's tournaments; and (3) special thanks to LaRue Briggs of Lakewood who directed ladies golf at 5 super courses. Forty eight men played at Azalea Sands, Beachwood, Surf, Deer Track and Litchfield. 42 men were winners who shared 70 prizes. Hobart Henline and Doug Lenardson (Eaglehead and Cambridge respectively) won in 4 tournaments. 5 men won in 3 tournaments 13 men in 2 each. Biggest winner was Hobart Henline with \$42.50 in his mad money pocket.

SUMMARY OF ACTIONS TAKEN MISGA BOARD MEETING OF APRIL 23, 1981 AT PENN NATIONAL

THE FOLLOWING MOTIONS WERE PASSED:

Rescind previously passed motion permitting Board members to compete in the Fall Championship without qualifying.

Sell MISGA bag tags @ 50¢ each.

Establish Ad Hoc planning committee to develop both short- and long-range posture for MISGA activities.

Grant Wakefield Valley membership in MISGA

Appoint Ad Hoc committee for 1982 to investigate feasibility of holding the 1982 Spring Fling at Foxfire (near Pinehurst) with capacity for up to 280 Associates at an "affordable" price.

Appoint an Ad Hoc committee on communications to develop a communications policy with a preliminary report for the June Board meeting.

Major tournaments schedule for 1982 will be presented to the Board at the June meeting by the Tournament Committee.

MISGA's current operating condition is to be reviewed by the Liaison Committee at the June Board meeting.

MISGA's expenditures will not exceed approved budget of 10/80 without Board approval with the proviso that individual categories may exceed authorizations as long as the total budget is within the set limit.

MISGA clubs are authorized to set their own fiscal policies with respect to all local events.

Slots for two man teams for the Fall Championship qualifying round will be allocated to clubs in proportion to their membership with two provisos: each club is guaranteed a minimum of one team and selection of qualifiers will be based on the results at each of the three clubs used as qualifying sites --not among the three clubs. This decision was based on eliminating differences in course difficulty and weather conditions. It was further agreed that if not all qualifiers from any site show up, additional qualifiers would be selected by going down the list (of best net scores) for the site involved to select "standby" teams.

MISGA'S GUARANTEE POLICY:

<u>Players:</u> Misga will not guarantee a specific number of players in its major tournaments although clubs will be kept advised on what our planned numbers are.

Meals: meals are paid for on the actual number dining; Club is advised before play starts

Disasters: In the event of tornadoes or monsoons Misga will pay for predisaster contracted for items e.g. food, carts, special waiters which cannot be canceled.

Individual actions: Misga is not responsible for the actions of Associates. Withdrawing Associates are responsible to get a substitute. In emergencies, such as sickness immediately before an event, refunds will be made only to the extent recoverable.

To all who stayed at home -- sorry for you this time but don't miss the 1982 Spring Fling. It will be twice as big as in 1981 and no doubt the event of the year.

MISGA FALL CHAMPIONSHIP TOURNAMENTS

The fall qualifying tournament is a 2-man better-ball, full handicap with no limits on the combination of handicaps of partners. All clubs will have at least one team entrant in the championship flight provided they show up at the qualifying trials. The qualifying trial sites are: Tantallon, September 9; PineyBranch, September 10; and Nassawonga on a date to be announced.

How many 2-man teams will each club have in the fall qualifying?

The number of teams is determined by the size of the club's MISGA membership relative to the total MISGA membership. It is further dependent upon the total number of qualifying spots available at the three qualifying sites. For example, assume that MISGA has 1700 members of which 400 are on the eastern shore and 1300 on the western shore. The two qualifying sites on the western shore can accommodate 72 2-man teams each. Further, assume that the western shore clubs are so divided that the total MISGA membership of the clubs qualifying at each site are the same and equal to 650. Therefor, if 650 members warrant 72 qualifying teams, then 400 members (* in the eastern shore clubs) warrant 400/650 times 72= 44 teams. So, we have 72 teams qualifying at sites 1 and 2 and 44 teams at site 3. Now, if you are a western shore club and have 55 MISGA Associates you may send 55/650 times 72 = 6 teams to qualifying.

In actuality, the number of teams which each club may send to qualifying will depend upon the number of paid MISGA Associates recorded as of June 1, 1981.

Using an idealized example:

In the following example 28 teams from both Tantallon and Piney Branch and 16 teams from Massaconga would be selected to go to the championships at Lakewood on September 13th.

which of the qualifying teams go on to the championship?

First, at each qualifying site each club's team which has the lowest qualifying score with respect to their club's other teams is an automatic qualifier. In other words, each club is guaranteed one team in the championships provided it has qualified. The remainder of the quota for each qualifying site is then filled by teams in the order in which they finished in terms of score, regardless of their club affiliation. Therefor, using the idealized example again:

(NOTE: In contrast to last year's combined minimum handicap of 25 there is no restriction on what the combined handicaps of the partners in the 2-man t eam may be in 1981.)

At most clubs a well organized and administered \$eniors Golf program is one of the best cash flo assets of the club. Surprisingly, many clubs do not recognize this valuable asset.

If we want the clubs to recognize the value of \$enior Golf Programs it is up to us to toot our horn louder, more often and better than we have in the past.

First, we need to take a little trouble to total up the cash flo after each seniors event. How many carts were rented, how much prize money was awarded in proshop credit, what was the food bill or estimated food expenditure? Plus an estimate of the expenditures in the proshop and at the bar.

Second, you must tell the "man" about this. The "Man" may be the President of the club, the Chairman of the Golf Committee or the owner of club, this will vary from club to club. Each \$eniors Chairman or Club Rep. will know best to handle this in his club. But one suggestion is to notify the "man" after each \$eniors event as the amount of cash flo for the event. This means he is hearing about the \$eniors cash flo contribution to the club often enough that the \$eniors program will not be forgotten or sold short.

One Club kept a record last year and showed a cash flo of over \$16,000 for the year and the same club will probably show more this year. Another club has set a goal of \$20,000 for the year. When you keep a record or set a goal for yourself you are forced to realize that you must have an active \$seniors Program if you want that bottom line to be impressive at the end of the year. You will not end up with a big cash flo figure with a token Seniors Program. As many events as the club will allow should be scheduled. Additional MISGA Mixers are generally available. Other Special \$enior events can be held such as invitational tournaments, Member-guests etc. One club

\$eniors group invited the ladies of the club to play in a best ball foursome set up on \$eniors day. It was a big success with a cash flo just under \$1000. The ladies enjoyed it so much they want another Mixer this year. There are a lot of other ideas available.

Most Clubs are sensitive to the cash flo problem and we are missing a golden opportunity if we fail to keep our clubs informed as to what we are contributing and how we might be able to contribute more with better cooperation.

NOTE: Record keeping of cash flow has been an on-going objective for all MISGA clubs these past 3 years.
