Once again the Tournament Committee has arranged an outstanding program of activities for the non-golfing ladies. Special scenic bus tours are planned for both days. The Thursday tour includes a three-hour Chesapeake Bay cruise. The bus, boat trip, and lunches both days are included in the overall fee.

Lodging will be at four motels located close together on Route 13 north of Salisbury. Very attractively priced packages are available. The total cost for men golfers will be \$60 and includes lodging and dinner on Thursday, lunch on Friday, golf carts both days, and prize money. Greens fees are waived. The cost for golfing ladies will be \$90 for the 18-hole group and \$68 for the 9-hole group. Lodging and dinner on Thursday, greens fees, prize money, carts, and bus transportation are included for both the 9-hole and 18-hole groups. The cost for the non-golfing ladies who choose the bus tours will be \$71, including lodging and dinner on Thursday.

Lower package prices are available for both men and lady golfers who do not require lodging and for non-golfing ladies who do require lodging and/or who decide not to avail themselves of the bus trips.

Nayone who does not receive an entry blank by March 18th may call Bill Ransdell at 742-4531 or see the MISGA Rep at your club. Remember - time is of the essence. Entries are cut off at 288. Last year this event was oversubscribed by more than 50 entries, so respond promptly if you wish to participate. Hope to see you there!

POXFIRE PALL FROLIC CONTINUES TO GRCW

What has become an annual Fall trip to Foxfire continues to grow in popularity. On our first visit there in November of 1981, only about a hundred MISGA members and their wives participated. After skipping 1982 because of a trip to the Bahamas, November of 1983 saw a group of 157 of our members and their wives enjoying five great days of golf, fun, and fellowship at the Foxfire Inn and Country Club in the sandhill country of North Carolina near Pinehurst. Moving on to this past November we had a capacity crowd of just over 200, with another group of 40 people who wished to go but who could not be accommodated. In order to avoid again disappointing a large number of people, President Sam Hastings is trying to arrange for us to have two groups going to Poxfire this coming Fall, with from 150 to 180 people per section, with the following dates: Section 1, October 28 to November 1, and, Sec-tion 2, November 4 to November 8. Sam hopes to have this finalized in the near future.

Why is the Foxfire Fall Frolic becoming so popular? Primarily because the accomodations, the food, the two championship golf courses, and all of the other facilities are truly outstanding. Furthermore, the cost of the packages for both golfers and non-golfers represents a really great value.
