THE STATE OF MISGA

I hope I am not being too pretentious by stealing the concept of another President by calling this a State of MISGA report. In counting back I see that I am the ninth President of MISGA; I hope I do not imitate the ninth U.S. President who died in office.

I am honored to have been elected President of this fine orginization. I am also fortunate to have Vice-President, Board of Directors and Staff who are experienced, knowledgeable and inovated. I believe this team will make this year another outstanding one for MISGA.

Some of the things we have accomplished this year were initiated under the able leadership of Bob Fuchs. Changes were made in the election process for Board Members, the most important being increasing the terms of all future members from three to four years.

As mentioned in our last MISGAGRAM, we now have a general counsel, Joe Malinowski, and that should aid us and give us comfort. And now we have Division Association Chairmen to report to our MISGA Associates Chairman to help us keep track of our members and improve communication.

I have asked the Policy and Planning Committee to prepare a Handbook For Club Reps that should insure uniformity and fairness in the conduct of all MISGA events. And we have under considersation forming a hole-inone club.

Now I would like to sermonize a bit about things that bother me and, I am sure other MISGA associates.

There seems to be a trend, in some instances, away from the Basic MISGA Principles as we have grown bigger but not necessarily better. The wise men who founded MISGA envisioned a friendly, noncompetitive organization whose members would visit and play at other clubs and then sit down to break bread and get to know each other better. Prize money was kept low so that the competition would not interfere with friendship. That was 13 years ago and the original proud 12 clubs have grown to 43 and membership will probably top 4,000 this year.

I think it is time to reaffirm our principals. Clubs must be willing to play all clubs on their assigned schedules. Associates should participate in at home as well as away MIXERS. Participants in MIXERS should stay after the match for lunch and members of the home club should act as hosts. And, finally associates should participate in the whole MISGA program including weekly play, Mixers and tournaments. MISGA was not set up to be a travel agency promoting cut-rate golf vacations.

I hope that the Board will set up guidelines whereby the faithful MISGA associate who participates in home and away mixers and who doesn't head home after the golf is over (and he happened to have a bad round) and who treats his guests with hospitality will be given priority on sign-ups for all MISGA events.
