PRESIDENT'S MESSAGE

There are still vacancies for each of the Fall trips. It is not too late to avail yourselves of a great experience.

The Board of Directors authorized a survey of our 50 Clubs to help gather information and to learn of problems facing our Club Reps. Three common problems showed up on several of the answers:

- 1. The "no show". The last MISGAgram emphasized this problem. Need more be said???
- 2. The failure of members to record scores for handicap purposes. One Club, trying to curb this situation, allows a member 72 hours to post a score. If it was not done within that time frame, the Pro and/or Handicap Chairman takes the lowest previously posted score, subtracts 5 from it, and posts that as the score for the MISGA Mixer. That does get your attention!
- 3. Griping by non-MISGA members over waiving of green fees for MISGA Mixers. They call it MISGA's "free ride".

In response to the criticism that guests at MISGA Mixers are "free loaders", let's examine the facts. These guests are paying from \$20 to \$28 for cart rental, luncheon and prize money. Further, we require MISGA home players to use carts, buy lunch and pay prize money. Unless a Club has a mandatory cart use requirement, this procedure generates additional income since many members prefer to walk during their regular rounds of golf.

The assumption that green fees from visitors is lost revenue is valid only if we assume that the 30 to 60 guests arrive at your course for a non-MISGA round of golf. It just does not happen that way. Without the Mixer policy of waiving green fees we would not be visiting other Clubs as a group.

The bottom line is that a Mixer brings in guest money which would not be generated otherwise. It also captures additional funds from local members by requiring carts, lunch, etc. In our survey, those Clubs holding ten or more Mixers report gross MISGA income for the season ranging between 20 and 30 thousand dollars annually. Not bad for using 10 or 12 half-days out of 214 days in the golfing season (1 April to 31 Oct.)

MISGA has every right to be proud of its contribution to each member Club. MISGA availability serves as both a senior membership recruitment and retention tool for the Club. To deny its contribution, or that of other Club groups, is foolhardy and shortsighted.

Second sentence: place a period (.) after the word "Associates" and delete the last three words (including handicap data).

The "Club Representatives Handbook" is under revision and new pages effected by the changes should be available in the near future.

All Associates are reminded that at a MISGA Board of Directors meeting on September 16, 1993, the annual Associate dues were raised from \$2.50 to \$4.00 effective in 1994.
