- 2. Roy Gauzza distributed copies of Associate Rosters to Division Directors and announced that the present membership of MISGA is 4485.
- 3. The representative of Potomac CC announced that as of April 1, 1996 his club has changed it's name back to Tantallon CC.
- 4. The representatives voted unanimously to make the following changes to MISGA's Constitution and By-Laws:

Replace Article VII, Section 1 with the following: "MISGA is organized in five geographical divisions. They are: Division I - Eastern Shore North, Division II - Western Maryland and Baltimore, Division III - Washington East, Division IV - Washington West and Division V - Eastern Shore South."

Replace Article VII, Section 3 with "Each Division will elect a Division Director and an Assistant Director each of whom will serve as Directors on the parent MISGA Board for a four-year term. They are elected by the Club Representatives in their respective Divisions."

Change Article V Section 9 to "Section

9. Trips Committee: (a.) this committee will consist of members from each Division, some of whom are responsible for each Trip (Fling) in the Winter, Spring and Fall seasons. (b.) The Committee shall decide which resorts and/or clubs shall be used for each affair, and recommend them to the Board of Directors for approval. (c.) The Committee Members involved shall have the responsibility and management for each trip (fling)."

Change the old Section 9 to "Section 10." Change the old Section 10 to "Section 11" Change the old Section 11 to "Section 12"

TRIPS COMMITTEE NEWS

The Fall Frolics - Fripp Island oversubscribed on 2nd day, some openings still available at Sea Trail and Seabrook.

Out-of-State" Events Survey - The number of responses was very disappointing, 190 of a possible 4485, a 4.2% return, with only one-half of the member clubs represented. The results indicate that 84 had attended "out-of-state" events and 106 had not.

The reasons given for non-attendance: a. too expensive (10%), b. too far to travel (8%), c. event too long (3%), d. prefer traveling with smaller group (11%), e. need more information (11%), f. nothing for non-golfing spouses to do (15%), g. just not interested (20%). Most of the other reasons given involved their spouses, e.g. not interested, doesn't play golf, illness, still working, etc.

The response from the group who have

been attending "out-of-state" events was positive and indicated а general satisfaction with most aspects of the current program. However, this group did express concern about activities for their non-golfing wives. This concern has been duly noted. Although there has been no general dissatisfaction with the present venues, the overwhelming response to Fripp Island indicates a strong interest in new and different venues.

Scotland/Ireland - It has been 10 years since a MISGA group visited Scotland. So, at the last MISGA Board meeting the Trips Committee was authorized to plan another trip to Scotland/Ireland for September 1997. Note this on your calendar and we'll keep you informed.
