BOARD MEETING HIGHLIGHTS

The Board of Directors met at Prospect

Bay on September 26, 1996.

- 1. After an extensive discussion President Meyer appointed an ad hoc committee consisting of Frank Page, Paul Desmond, Tim Harris and Joe Malinowski to examine the problem of MISGA Clubs having less than 25 members. They will report recommendations at the next Board meeting.

 2. Historian, Ray Keany suggested that President Meyer send copies of MISGA's
- President Meyer send copies of MISGA's new history to St. Andrews, the USGA, PGA, MidAtlantic Golf Association, the Golf Museum, some major Golf Magazines and Maryland and Delaware State Golf Associations. It was moved and passed that the President should do so.
- 3. George Lipscomb suggested a new way of breaking ties in MISGA tournaments. After much discussion, President Meyer appointed an ad hoc committee consisting of George and all Division Tournament Chairmen to develop a proposal for consideration at the next Board meeting.
- 4. General Counsel, Joe Malinowski explained the By-Law changes that were distributed with the meeting agenda. The Board approved the changes which will become effective if approved by Club Reps at their Annual Meeting in April 1997.

Change Article II Sections 2 and 3 to read as follows:

"Section 2 - The term of office for newly elected Division Directors and newly elected Board Members shall be four (4) years and as their respective terms expire, the vacancies thus created shall be filled by the election of successor members; however, at the expiration of their respective terms, the Assistant Division Director will move up to Division Director and the newly elected Director shall become the Assistant Division Director. Such elections must take place prior to September 15th of the fiscal year. No elected Division Director or Assistant Division Director shall run to succeed himself on the MISGA Board until he has at least one year absence from the Board, whether he was elected to succeed an outgoing Director or assume a Directorship through a special election."

"Section 3 - In the event that a vacancy on the Board shall occur due to death, resignation or other cause, the affected Division shall elect a Board member to fill the unexpired portion of the term subject to the succession stated in Section 2"

- 4. Duke Rowden announced that there was a potential new MISGA club: Wild Quail (located near Dover, Del.)
- 5. Frank Page reported that John Rooney was elected to succeed George Meyer on the Board in Division II.
- 6. Wayland Coston announced that Bob McMinn was elected Assistant Director in Div. IV.
- 7. Otis Jefferson said that Jack Nichols was elected to succeed him in Div. V.
