CONSTITUTION AND BYLAW REVISIONS

Club representatives attending MISGA'S Annual Meeting were asked to vote on a proposal to revise MISGA'S Constitution and Bylaws. The revisions were developed in response to the MISGA Board's need to be able to respond promptly to problems which arise during the year. Under the former Constitution, any change in the Constitution or Bylaws could only be approved by an

affirmative vote of a majority of the Club Reps attending the Annual Meeting. Over the years, a number of very detailed procedures and specific requirements had accumulated in the Bylaws. Many of these items are subject to change over time, and under the old Constitution, could only be changed at the Annual Meeting. This requirement often prevented the Board from responding rapidly to what are essentially its management duties.

The revised Constitution eliminates the need for approval at the Annual Meeting for Bylaw changes, but also incorporates a number of safeguards in the Constitution to prevent the Board from taking actions which should be approved by the entire Club Rep body. The Constitution now contains descriptions of the Board of Directors and the term limits of Directors. The Constitution cannot be revised unless two-thirds of all Club Reps approve the changes at the Annual Meeting, but the Board can make changes to the Bylaws. The Board intends to notify the membership throughout the year, and at the Annual Meeting, of any changes made to the Bylaws. If the Club Reps object, such changes can be reversed.

Discussion of the proposed revisions at this year's Annual Meeting demonstrated the Club Reps' concern for the new provision that Assistant Division Directors will automatically succeed the Division Directors when their terms end, or when they resign. The Board indicated that it will review this provision to address the Club Rep's concern, and will report back on what action if any is to be taken.

When the vote was called, the Club Reps voted 45 to 0 to approve the revised Constitution and Bylaws. A revised version of the Constitution and Bylaws will be prepared and distributed to the Reps for inclusion in the Reps Handbook.

DUTIES OF THE ASSOCIATES CHAIRMAN

The function of the Associates Chairman is described in Section VI of the MISGA Bylaws. The responsibilities are: 1) the collection and recording of Associates dues and transfer of such funds to the Treasurer; 2) the preparation of a roster of all MISGA Associates; 3) the coordination of roster records with the Treasurer.

Rosters of the Associates from the MISGA clubs and the collection of dues are managed by the Club Reps. Please note that the Reps fill out roster change forms with additions. deletions and changes and send these along with dues to their Division Associates Chairman who forwards them to the MISGA Associates Chairman. Associates The Chairman maintains a spreadsheet of dues collected, and current roster status and forwards all checks to the Treasurer. Chairman uses a computer services company to do the actual roster maintenance and uses those roster counts to resolve any differences in roster count and dues paid by the clubs. Updated rosters are provided four times a year to the Division Directors for distribution to the Clubs and the Division Associates Chairman. The Chairman maintains a Master copy of the Club rosters and also one copy alphabetized by name.

There are a number of other functions not spelled out in the Bylaws. The Chairman also provides, through the computer services company, mailing labels for four MISGAGRAM mailings per year and labels for the Board members and Club Reps for the December Board Bash. A list of deceased members is maintained and supplied to the MISGAGRAM Editor for inclusion in the MISGAGRAMS. Bills for computer services

are audited and sent to the Treasurer for payment. Our 1999 budget is \$2300.00

In addition to the above, the Chairman of the Associates Committee is a non-voting member of the MISGA Board and attends Board meetings to provide status reports.


